## PRESIDENT'S MESSAGE

#### Fleet Week 2010 and Broward Council—The sea services highlight of the year

There were seven ships, 2,200 sailors and marines, a total of seven days replete with numerous planned activities, ship tours, community outreach visits, shipboard receptions, athletic events, lunches and dinners which honored many ranks and ratings, a fishing tournament, civil and military dignities, Marlins baseball and much more.

Congratulations to Humana Military Healthcare Services, the sponsor, and to Broward Navy Days, the organizer, with Joe Millsaps constantly on the quarterdeck. If you have an affinity for seafaring and seafarers, Broward County was the place to be. At virtually no cost.

Broward Council, as always, was well represented. We provided one third of the 95 make-the-events-go-smoothly volunteers under the tutelage of Don Bannister and Joe Giambrone. Don, and Phyllis, assisted by the Heins and the Steins, manned a mini water barge at the entrance of Pier 26 where they not only directed tours to the USS IWO JIMA, but also sold bottled water, at give away prices, garnering over \$500 for our Council which covers the costs of one of our JROTC scholarships. Tom Jones, for several weeks before and after Fleet week, went deep underground and manned the Combat Information Center, electronically routing over 10,000 visitors on ship tours. And actually located them all afterwards.

Boatswain John Kiefer, after reviewing his marlinspike manual and checking the paint locker, lead a contingent of off duty sailors to several sites in Fort Lauderdale to work on Habitat projects after which John treated all to lunch. John's workday started at 0630. And no grog allowed! Joe Giambrone spent the entire week supervising the check in counters at Piers 21 through 25.Peter Caspari not only helped to arrange the Fishing Tournament but also took several thousand pictures of all aspects of Fleet Week. Peter was the only one allowed to give the CNO and indeed other visiting flag officers specific orders.....which they obeyed.

The Junior Officers' Party, which your Council sponsored at Briny's Pub, attracted 135 JOs, 32 former crew members from the USS Aucilla, a decommissioned fleet oiler, combined with an excellent turnout of Council members. Briny's was rockin' as never before. Erwin Sefton took care of all arrangements, and in addition he coordinated the guest list for the outstanding reception aboard the German frigate HESSEN. Some 200 invitees attended, the evening was exceptional, and Capt. Dirk Gaertner introduced Erwin and awarded him an elegant plaque.

The Postal Service issued a commemorative set of four stamps, all depicting Navy Heroes of the past. Distinctive enlargements of the four stamps were placed in an elegant frame and awarded to the CNO and several senior officers as remembrances of Fleet Week by the Postmaster of Fort Lauderdale. Joe and Marianne Giambrone arranged for his participation in the event aboard the Iwo Jima.

Senior Chief Alan Starr served as ship liaison for the well attended and wildly praised CPO reception at the Coral Ridge Yacht Club, indeed an outstanding event of the Week.

## MARITIME AND SEA SERVICE NEWS



On May 7th, family members of USS Arizona survivor Anthony Schubert joined representatives from the National Park Service and Navy Region Hawaii for a private memorial ceremony and interment onboard the USS Arizona Memorial. Schubert, a veteran of the December 7, 1941 attack on Pearl Harbor aboard the USS Arizona, passed away at the age of 90. The USS Arizona was Schubert's first duty station after graduating from the Naval Academy in 1940. After the ceremony, Schubert's urn was carried from the memorial to the dock area and presented to National Park Service divers, who took the urn into the open barbette of gun turret number four and proceeded down the barbette to a large open "slot" that measures approximately six inches by five feet. The urn was then placed into this slot and into the ship where Schubert will rest with his ship-

mates. Following the interment of the urn, Schubert's family was escorted into the Shrine Room, where they removed the black clothe to reveal his name, which is now forever etched on the interment wall. He was the thirty-third survivor who choose to be reunited with his shipmates.



The future USS Jason Dunham (DDG 109), the 58th ship of the Arleigh Burke-class, successfully completed a combined builder's and acceptance "super trial" on May 20, after spending four days at sea operating in the Atlantic Ocean. Because of the maturity of the class, the Navy holds only one round of trials on each ship prior to delivery, instead of separate builder's and acceptance trials. This "super trial" requires less time, fuel and manpower than the typical method. During the trial, Bath Iron Works and the U.S. Navy's Board of Inspection and Survey tested the ship's weapons, communications, and propulsion systems as well as conducting several other inspections including habitability, water purification and food preparation. These trials are the last significant milestone before delivery of the ship to the Navy. The future USS Jason Dunham is expected to deliver this summer and to be officially commissioned in Port Everglades in November.



The commander of U.S. Fleet Forces (USFF) praised generations of U.S. merchant mariners for their contributions to the nation's defense at a ceremony attended by more than 200 people during Military Sealift Command's National Maritime Day observance at the Washington Navy Yard in Washington, D.C. on May 18. National Maritime Day was established by Congress in 1933 to honor the contributions and sacrifices of U.S. merchant mariners in defense of the nation. These dedicated men and women are frequently considered the unsung heroes of the nation's defense. Commander, Military Sealift Command, Rear Adm. Mark H. Buzby, hosted the event and expressed his gratitude to the thousands of civilians who crew MSC's ships. MSC, the single largest employer of U.S. merchant mariners in the world, employs more than 5,000 civil service mariners and more than 1,500 commercial mariners who work for private ship operating companies under contract to MSC. Merchant mariners have been a vital component of American sea power since

the Revolutionary War when more than 11,000 mariners died in service. Today, mariners continue to play a critical role in the nation's defense, enabling the U.S. military to operate around the world

Congratulations to our community affiliate Resolve Marine.

Resolve Marine Group has received the U.S. Coast Guard's approval and recognition from the International Group of P&I clubs for their OPA 1990 Vessel Response Plan Salvage (VRPs) and Marine Firefighting Funding Agreement. Resolve's Funding Agreement is the first OPA-90 mandated document of its kind to receive this combined international acceptance. Under new requirements scheduled to go into full effect in February 2011, tank vessels carrying oil as cargo must submit a revised VRP to the Coast Guard in order to operate in U.S waters. Each VRP must be accompanied by a signed funding agreement committing a qualified salvage and marine firefighting resource provider to respond in the event that vessel suffers a casualty involving an oil spill or the substantial threat of a spill. For the past fifteen years, Resolve has extended emergency response coverage to thousands of tank vessels that carry oil in U S waters. Resolve Marine Group is a multi-faceted marine services company based in Fort Lauderdale with response depots in Alabama, the United Kingdom and Singapore.

## **COAST GUARD NEWS**



Coast Guard Air Station Miami took receipt of its first HC-144A Ocean Sentry Maritime Patrol Aircraft. Arrival of the aircraft is a significant milestone in the standup of HC-144A operations throughout the Coast Guard. The HC-144A replaces the HU-

25 Guardian turbo-fan in performing medium-range maritime patrol missions. Air Station Miami is the second Coast Guard air station to obtain the HC-144A. Flight crews are familiarizing themselves with the unique operational characteristics, capabilities and systems of the Ocean Sentry and maintenance crews have commenced routine servicing, inspections and ground handling procedures.



A change of command ceremony was held on May 13 for the Seventh Coast Guard District commander at Air Station Miami in Opa Locka. Rear Adm. Bill Baumgartner assumed the responsibilities as the Seventh Coast Guard District commander and Director of Homeland Security Task Force-Southeast from Rear Adm. Steve Branham. Branham retired after 37 years of honorable ser-

vice to the Coast Guard. Prior to assuming command of the Seventh District, Rear Admiral Baumgartner served as the Judge Advocate General and Chief Counsel of the United States Coast Guard. Rear Admiral Baumgartner is a native of Collinsville, IL and a graduate of the U.S. Coast Guard Academy where he received Bachelor of Science degrees in Marine Engineering and Electrical Engineering. He holds a Master of Business Administration degree from the University of New Orleans and a Juris Doctor degree, magna cum laude, from Harvard Law School where he also served as an editor on the Harvard Law Review.




## **OUTSTANDING JROTC CADETS**
