## COMMISSIONING



The next new Fast Response Cutter, the USCGC ROBERT YERED, will be commissioned on February 15 at Coast Guard Base Miami Beach. This vessel is named after Coast Guard Hero, Engine-

man First Class Robert J. Yered whose fearless actions set him apart as he stood duty in the explosive loading detail at the United States Army Terminal, Cat Lai, Vietnam, on February 18, 1968. In the early morning hours, the terminal at Cat Lai was attacked by enemy rocket, mortar and small arms fire. As the heavy rounds beat into the terminal, one of the rockets struck a barge carrying several hundred tons of mortar ammunition. The barge was quickly engulfed in flames and threatened to destroy three nearby ammunition ships carrying more than fifteen thousand tons of explosives. Engineman Yered courageously exposed himself to enemy gunfire as he helped extinguish fires on the burning barge. His bold act averted not only the destruction of his own ship but also that of the entire terminal. Yered's valorous character shone through many times throughout his career and he is one of 12 Coast Guardsmen awarded the Silver Star. Among his other awards are the Vietnam Service Medal with four bronze stars and a Purple Heart Medal.

Broward Navy Days and its partner organizations, including our Council, met with Navy officials on January 15 at Port Everglades to begin preparations for Fleet Week 2013. This year's Fleet Week will run from April 29 through May 6 with 5—6 Navy and Coast Guard ships expected to visit South Florida. Many of the most popular events will be returning including the Damage Control Olympics, Celebrity Chef Luncheon, Salute to Veterans, Galley Wars, visits to local schools and hospitals and the Council's Junior Officers Party. A full schedule will be available in late February or early March.

Each year, more than 8,000 people, including school, church, scout and veterans groups, tour the visiting military ships in port for Fleet Week. Due to security restrictions, requests for tours must be made online in advance. ## COUNCIL CHALLENGE COIN



Did you know the Council has its own challenge coin?

According to Wikipedia, a challenge coin is a small coin or medallion (usually military), bearing an organization's insignia or emblem and carried by the organization's members. They are given to prove membership when challenged and to enhance morale. In

## NEWS FROM SEAFARERS' HOUSE



Seafarers' House Shoebox Christmas Program delivered packages to 1,345 visiting seafarers from 41 countries on board 73 ships in Port Everglades and the Port of Palm Beach. The majority of the crew members (43.2%) were from the Philippines. Board member Joe Giambrone served as the coordinator of the volunteers who delivered the packages. Several

Council members volunteered their time to take part in the deliveries.

Many of the mariners work for months aboard ships that take them away from their families. They put in long hours and often do not have opportunities to get off the ship. They were very appreciative to be remembered at Christmas and both the crewmembers and those volunteers who delivered the packages benefited from the experience.

It is hoped that more Council members will serve as volunteers for the Shoebox Christmas Program next year. If you are not physically able to deliver the shoeboxes, there are usually opportunities to wrap and fill the boxes.

The International Committee for Seafarers Welfare (ICSW) has awarded its Seafarers Centre of the Year 2012 Award to Seafarers' House in Port Everglades for the outstanding services they provide. The awards ceremony was a glittering event in the General Assembly at the UN's International Maritime Organization in London. Lesley Warrick (shown in photo with award), Executive Director of Seafarers' House, accepted

the honor at the ceremony. What makes a good seafarers center the best in the world? According to Lesley Warrick, two things certainly stand out at the Port Everglades Seafarers' House: knowing what seafarers want ("We work hard to foster an atmosphere that is respectful, caring and never patronizing,") and collaborating with partners to deliver what seafarers want ("Crew repeatedly tell us how friendly our team is and how they can find whatever they need in our centre.")

Seafarers' House accomplishment was acknowledged at a luncheon hosted in Fort Lauderdale by the Port Everglades Association, where Broward County Commissioner Chip LaMarca presented a resolution from the Broward County Board of County Commissioners. The accomplishment was also acknowledged at a reception held at cruise terminal 18 at Port Everglades on January 30.

Seafarers' House is the busiest such agency in the world, annually hosting more than 100,000 visits by cruise and cargo ship crewmembers.



## SEA SERVICE NEWS



Coast Guard Cutter Dependable offloaded 1,210 pounds of cocaine with an estimated wholesale value of more than \$14 million to Homeland Security Investigations in Key West in mid-January. An MH-65 Dolphin helicopter crew from Helicopter Interdiction Tactical Squadron (HITRON) Jacksonville deployed with the Coast Guard Cutter Forward (shown in photo), noticed two suspicious vessels detected in the vicinity of Guanaja, Honduras. The cutter Forward and Coast Guard Cutter Confidence were diverted and launched their two small boat crews to stop and board the go-fast vessels. During the pursuit, the aircraft crew observed a go-fast crewmember jettison multiple packages in the water. The HITRON helicopter employed warning shots and disabling fire to compel the vessels to stop. The Forward and Confidence small boat crews subsequently arrived on scene, boarded the two vessels, and detained eight suspected smugglers. The 22 packages were recovered from the water and later tested positive for cocaine.



The USS Guardian, a Navy mine-sweeper that is based in Japan, crashed into a Philippine reef before dawn on January 17

while on its way to Indonesia after making a rest and refueling stop in Subic Bay, a former American naval base west of Manila. All of its 79 officers and crew were transferred to two other U.S. vessels the following day for safety reasons as the 74-yard long, 1,300-ton ship was unable to maneuver on its own and buffeted by strong winds and waves. The ship is hard aground about 30 meters from the edge of the reef, a marine sanctuary that is a UNESCO World Heritage Site. On January 24, it was reported that the minesweeper was damaged and taking on water and would have to be lifted off the rocks in an operation that could last a week or two. An investigation will look into all the factors that may have led to the grounding, including a reported faulty digital chart, sea conditions, weather and the state of the ship's navigational equipment. The Philippine government said it wants to fine the Navy for the damage and illegal entry into the marine sanctuary. The Navy said that after the ship is removed, the damage to the reef would be assessed and the two governments, which have close military and political ties, will discuss any claims.



A Marine and a sailor serving with 1st Light Armored Reconnaissance Battalion received the Bronze Star with combat distinguishing device during a ceremony at Camp Pendleton on January 23. Sergeant Thaddeus Herber, an infantryman, and Petty Officer 3rd Class Mark Connolly, a corpsman, received the Bronze Star from Maj. Gen. Ronald Bailey, the commanding general of 1st Marine Division, for their actions in Helmand province, Afghanistan in 2011. Herber, a native of New Braunfels, Texas, and his squad of Marines were ambushed by small-arms fire. He led two Marines forward into a ditch to return fire. A fellow Marine called over the radio and said that the enemy was shifting to return fire along the ditch. Immediately, Herber ordered the two Marines in his team to get out of the ditch and noticed a combat engineer had taken a gunshot wound to the thigh. Without hesitation, Herber applied a tourniquet to the Marine's leg and dragged him behind a wall to safety. In a separate incident, Connolly, a native of Corvallis, Montana, and his squad were on a patrol when they were also ambushed by small arms fire. During the firefight, a Marine received a gunshot wound to the leg. Connolly applied medical aid to the wounded Marine as bullets impacted the ground around him. The Bronze Star is the fourth-highest combat decoration in the United States military. It is awarded with a combat distinguishing device for acts of valor in a combat zone.



Navy Divers at Naval Station Guantanamo Bay, Cuba, were awarded Navy and Marine Corps Achievement Medals on January 23 for helping save a life. Commanding Officer Capt. J.R. Nettleton presented the awards to four Navy Divers

for their role in rescue operations that took place as a civilian diver was in distress in base waters on January 20. "Upon surfacing, the civilian diver realized there was weakness and tingling in the arms with a headache and nausea," said NS Guantanamo Bay Unlimited Diving Supervisor Navy Diver 1st Class Christopher Kerr. "The diver went to the emergency room at U.S. Naval Hospital Guantanamo Bay and was assessed by the doctors as having a diving disorder. The ER contacted the Duty Response Chamber Team and from there was evaluated by Chief Navy Diver Richard Bolen and was diagnosed with Decompression Sickness Type II." According to Kerr, without proper treatment, there was a high possibility of permanent loss of motor functions in the arms with a chance of numbness and areas of permanently decreased sensation possible.
