# CAPTAIN AUSTIN J. GOULD US COAST GUARD COMMANDER, SECTOR MIAMI

Captain Gould has been assigned as Sector Commander since June 2013. He was previously assigned

to the Research, Development, Test and Evaluation (RDT&E) Program Manager at Coast Guard Headquarters since 2009, where he oversaw the Coast Guard's Research and Development Program, including the 100-person Research and Development Center in New London, CT. He also managed the Test and Evaluation Program for the Coast Guard's new complement of cutters, aircraft, and Command and Control systems.

Prior to being assigned to the RDT&E Program, CAPT Gould served as the Deputy Sector Commander at Coast Guard Sector Baltimore from May 2007 to May 2009. His first assignment in 1988 was as a Deck Watch Officer aboard USCGC VIGOROUS (WMEC 627). His career changed course when he was assigned as the Commanding Officer of Coast Guard Station New York in 1993, executing all search and rescue, law enforcement, and pollution response missions in the dynamic New York Harbor environment. This ashore command later resulted in his assignment as the Surface Operations Officer at Group-Air-Station Atlantic City from 2001 to 2003. He also served as the Boat Forces Platform Manager (CG-731) from 2003 to 2007, where he was responsible for the procurement, standardization, and maintenance of the Coast Guard's fleet of approximately 2,000 boats. .

Captain Gould's other administrative assignments include the Assistant Director of Auxiliary, First District, Southern Region, on Governors Island, New York, from 1990 to 1993. He also served as the Business Manager for the 47-Foot Motor Lifeboat Procurement project from 1996 to 1998 and as the Coast Guard's Governmental Affairs Liaison for the Coast Guard Congressional Affairs Staff from 1998 to 2001. During the 2010 Deepwater Horizon Spill of National Significance in the Gulf of Mexico, he served on the National Incident Command staff in Washington, DC.

Captain Gould is a 1988 graduate of the United States Coast Guard Academy, graduating with a Bachelor of Science degree in Government. In 1996 he earned a Master of Business Administration degree in Finance with an International Business co-major from the Stern School of Business at New York University. In 2011, he earned his Acquisition Level III Program Manager Certification from the Department of Homeland Security. Captain Gould is a native of New Fairfield, CT and is married to Coast Guard Commander Kathryn Dunbar of Columbia, SC. They have four children.

# NAVY LEAGUE LEGISLATIVE AFFAIRS

The following information was sent to all Navy League members who have a current email address on file. It is being provided here for those who may not have had an opportunity to review this information.

#### Support Legislative Affairs today!

The Legislative Affairs Committee is taking Navy League's grassroots advocacy to the next level and they need your help! A lead donor has stepped forward with the initial funding to set up an online engagement tool - CQ Engage Software. Now we need your help to reach \$12,200 and put the system into action. This amount pays for the licensing of the software. Only \$7,200 is needed. Give today and designate your gift to "legislative affairs" to ensure this program is put into place. Go to the Navy League website (navyleague.org), click on "Giving" and then select "make a gift online".

# What are online engagement tools and why does the Navy League need them?

Online engagement tools can make the process faster and easier for our members to contact their Congressional representatives, thereby increasing our impact on important issues affecting our sea services.

Current NLUS legislative advocacy process: The current system for contacting legislative representatives is very burdensome on the individual Navy Leaguer. Navy League headquarters writes the letters and emails, sends them out as word document attachments to all members, or just members of the Legislative Affairs Committee, balancing the urgency of the need with the desire not to overburden Navy League members. Navy Leaguers then have to look up their Congressional members' contact information, copy and paste the letter into the member's preferred format.

The solution: CQ Engage Software (formerly CapWiz)

With the new software, any Navy Leaguer can simply sign up for legislative alerts, log onto the web-based system, enter their contact information, including zip code, and just hit send on whichever issue matters most to them. Members will still be able to personalize the message if desired, but the new system would make engaging with Congress significantly easier on the Navy Leaguer and increase our impact in support of the sea services. Also, the system ensures only Navy Leaguers who want to receive this information receive it. It prevents the necessity of mass-emailing all Navy Leaguers regarding affairs of Congress. This system was chosen after extensive research and comparison of similar systems by both the IT Committee and the Legislative Affairs Committee, and both support this program.

Key features of CQ Engage Software:

- Allows the Navy League to effectively manage grassroots campaigns on a quick timeline and respond quickly as legislation is proposed and changed.
- Members can take action on the issues most important to them.
- Members can communicate directly with their legislators using a Navy League message.
- Navy League will be able to edit, add and change content on messages as needed.
- Provides up-to-the minute legislative information and contact information for federal legislators and their staff.
- Keeps Navy Leaguers informed with an automatically refreshing "Latest News" page.
- Will drive website traffic to the Navy League, as members can use the "Tell a Friend" and social media features to direct their contacts to our campaigns.
- Allows Navy Leaguers to determine who their Congressional representatives are and email them directly.
- Reduces burden on Navy Leaguers from having to look up the latest information.
- Provides metrics on how often Navy Leaguers contact members of Congress. This will allow Navy League to show our advocacy to the leaders of the sea services.
- CQ Engage Software is an easy way for regions to get members interested in legislative affairs.
- Navy League can maintain multiple campaigns at once on a wide variety of topics.

## **CUTTING CARRIERS**

The Navy has to strike a tricky balance on the numbers of carriers it fields between providing forces for U.S. military and finding enough money to operate and maintain the high dollar ships, the commander

of U.S. Fleet Forces said during a question and answer session following a Wednesday speech at the West 2014 conference in San Diego, California.

"We don't want to get rid of anything," Adm. William Gortney said. "The problem is that we have to match how much money we have in order to be able to maintain it. If we don't figure that out, we're going to be on the [fast] lane to hollow. And that's why you see the Navy has made some, put up some really tough choices on getting rid of some capability and capacity that we really need in order to do our missions."

Gortney's service's latest bid to reduce the carrier fleet — by decommissioning USS George Washington (CVN-73) when its due for its midlife refueling — has been stopped as part of the Fiscal Year 2015 budget due to White House pressure. Reducing the US carrier fleet from 11 to 10 has been a cost cutting measure the Navy has considered as a money saving option going back to at least 2011

Though the carrier is probably safe in the 2015 budget, there are increasing calls in Washington for the service to look for cost savings in reducing the carrier fleet and makes the ships a target in future budget submission. Operating an aircraft carrier can cost hundreds of millions of dollars a year in primarily the personnel cost of the 4,000 sailors in the combined between the ship's crew and air wing. Gortney addressed the loss of Washington directly saying that it would mean that any cost savings would mean higher operational tempo for sailors left to man the carriers. "The question is what is the impact say of GW going away really occur? The impact occurs in about [2021] which is supposed to come back into the rotation and we will go back to nine and 10 months deployments," Gortney said. "Just a single ship really matters in our ability....in our ability to generate the forward presence that we need."

Carrier deployments are scheduled for six months, but carriers have averaged nine to ten months in the last several years due to budget woes brought on by unexpected budget restraints and requirements to surge forces forward. In January, Gortney unveiled the Optimized Fleet Response. It is an FRP that will lead to eight-month deployments in a 36-month cycle that includes maintenance and readiness and would result in sailors being home 68 percent of the time. "I think eight months is the ragged edge of what sailors and families will be able to hold onto."

# TRAVIS: A SOLDIER'S STORY

On March 3, Past President George Reeves and his wife Rosa (shown below) attended the screening of "Travis: A Soldier's Story", at the University of Miami. It is a challenging documentary featuring the inspiring true story of United States Army Staff Sergeant Travis Mills of the 82nd Airborne. Travis lost portions of both arms and legs as the result of an improvised explosive device (IED) on April 10, 2012 while on patrol during his third tour of duty in Afghanistan. Travis is one of just five quadrupleamputees from the wars in Iraq and Afghanistan to survive such extensive injuries. The documentary featured powerful interviews and emotional reenactments from Travis Mills and his wife Kelsey as well as from fellow soldiers who witnessed the events of April 10th. Travis: A Soldiers Story is an intimate look into the life of a wounded solider as he faces the unimaginable physical and emotional challenges of this life-altering injury. Travis's story sheds light on the daily inward and outward struggles of our wounded veterans and the difficult rehabilitation processes they face; and Travis's openness and incredible perseverance challenge us to look at the way we deal with our own personal trials in life.



## **SEA SERVICE NEWS**



The Navy a c c e p t e d delivery of the third joint high speed v e s s e l, USNS Millin o c k e t (JHSV 3), from Austal

USA in Mobile, Alabama on March 21. Delivery marks the official transfer of the vessel from the shipbuilder to the Navy and is a major milestone in the ship's transition to operational status. Millinocket, the third ship of the JHSV class is commercially designed, with modifications made to suit military needs. The ship will transport troops, equipment, and supplies to littoral offload points over operational distances. She is designed to transport 600 short tons of military cargo 1,200 nautical miles at an average speed of 35 knots. JHSV 3 is equipped with a flight deck and an off-load ramp which allow for vehicles and helicopters to quickly access ports and quays. Littoral operations and port access are further enhanced by the ship's 15-foot shallow draft, ability to interface with roll-on/ roll-off discharge facilities, and ease of access to austere and deteriorated piers. This makes JHSV an extremely flexible asset, capable of supporting a wide range of operations including non-combatant evacuation operations, humanitarian assistance and disaster relief. USNS Millinocket will be owned and operated by Military Sealift Command (MSC) and will be manned by a crew of 22 civil service mariners.



Crewmembers aboard the Coast Guard Cutter Richard Etheridge offloaded approximately 1,500 pounds of cocaine, worth an estimated wholesale value of \$23 million in St.

Petersburg, Florida on March 17<sup>th</sup>. On March 12, during a patrol in the western Caribbean, crewmembers aboard the Coast Guard Cutter Tampa detected a suspicious gofast vessel moving at a high rate of speed in international waters. A Customs and Border Patrol Maritime Patrol aircraft provided oversight of the suspected vessel and the Tampa's onboard helicopter launched to pursue the vessel. Upon arriving on scene, the helicopter crew fired warning shots effectively stopping the vessel. A Coast Guard boarding team from the Tampa subsequently boarded the vessel and discovered 695 packages hidden inside the vessel's hull which later tested positive for cocaine. The Tampa is a 270-foot medium endurance cutter homeported in Portsmouth, Virginia



Maj. Kurt Chew-Een Lee, a Chinese-American who led Marines into battle against the Chinese in the Korean War and was cited for bravery for helping to preserve a crucial evacuation route for 8,000 American troops, was found dead on March 3 at his home in Washington. He was 88. Major Lee is believed to have been the first Asian-American officer in the Marine Corps. Slight of build at 5 feet 6 inches tall and 130 pounds, he

brought outsize determination to the battlefield, and his heroics have been recounted in books and a documentary film. Born in San Francisco and raised in Sacramento, he enlisted in the Marines toward the end of World War II and learned and then taught Japanese. He became a commissioned officer in 1946. (He retired as a major in 1968.) In addition to the Navy Cross and the Silver Star, Major Lee received many other military honors, including two Purple Hearts. Among other books, his exploits are recounted in "Colder Than Hell: A Marine Rifle Company at Chosin Reservoir" (1996), by Joseph R. Owen.



Cpl. Eric Roethler from O'Fallon, Missouri, and Sirius, a military working dog, wait to board an aircraft aboard the multipurpose amphibious assault ship USS Bataan (LHD 5). Bataan is the flagship for the Bataan Amphibious Ready Group and, with the embarked 22nd Marine Expeditionary Unit, is deployed in support of maritime security operations and theater security cooperation efforts in the U.S. 5th Fleet area of responsibility.



The Navy formally decommissioned Los Angeles-class attack submarine USS Miami (SSN 755) on March 28 during a ceremony at Portsmouth Naval Shipyard in Kittery, Maine. The event marked the end of Miami's nearly

24 years of active service in the fleet. The ship's first commanding officer, retired Capt. Thomas Mader, was the keynote speaker. Miami was commissioned June 30, 1990 as the Navy's 44th Los Angeles-class submarine. The photo shows USS Miami moored in Port Everglades in April 2004.
